1318. SHRI ROSHAN LAL: Will the Minister of STEEL AND MINES be pleased to refer to the answer to Unstarred Question 475 given in the Rajya Sabha on the 17th June, 1980 and state:

- (a) whether Government propose to consider the cases of the handicapped persons working on daily wages in the Unit office of the Steel Authority of India, New Delhi by giving the benefit of reservation of three per cent posts; and

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) and (b) In tune with the new objectives adopted by STC at the instance of Government and with a view to strengthining and expanding the supply base and infrastructural facilities, the Corporation plans to create export capacity for its own exports, through participation in joint ventures by providing assistance in technology transfer, marketing and financial participation, if necessary. To begin with, the Corporation has identified processed foods, marine products and leather products as items for promoting capacity creation units.

# Increase in employment costs and decrease in profits in public undertakings

1320, SHRI PILOO MODY: Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that in some public undertakings relating to contract and construction works, transportation services and financial services, there has been a big increase in the average emoluments of the employees in 1978-79 as against those in 1977-78, while there has been a big decrease in the earnings of these undertakings in 1978-79 as compared to the previous year; and
- (b) if so, what are the reasons for this anomaly?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI MAGANBHAI BAROT): (a) In the case of contracts and construction group, transportation services and financial services, enterprises listed below have reported lower pre-tamprofits in 1978-79 compared to substantially higher average emoluments in 1978-79 as compared to 1977-78;

Contracts and construction group:

- 1. Hindustan Steelworks Construction Ltd.
- 2. National Buildings Construction Corporation.

#### Transportation:

- 1. Indian Airlines
- 2. Mogul Line
- 3. Shipping Corporation of India

#### Financial Services:

- (b) Decreased profitability is attributable to several causes like higher costs of essential inputs (for example aviation fuel), delays in completion of the contractual assignments or the reduced demands for the products of the enterprises. The emoluments on the other hand register increases since these are linked to periodical wage settlements and rise in cost of living indices. The increased emoluments in one of the construction companies is attributable to segment of its being stationed outside India where emoluments understandably higher.
