THE MINISTER OF STATE IN THE MINISTRY OF LABOUR (SHRI T. ANJIAH): (a) and (b) A statement is laid on the Table of the House.

#### STATEMENT

To regulate the working conditions in certain sections of unorganised labour, "The Contract Labour (Abolition and Regulation) Act, 1970', The Inter State Migrant Workmen (Regulation of Employment and Conditions Act, 1979', 'The Beedi of Service) Workers and Cigar Workers' (Conditions of Employment) Act, 1966; and 'The Bonded Labour System (Abolition) Act, 1976' exist, in addition to other Central and State Legislation.

The Central Standing Committee on Rural Unorganised Labour constituted inter-alia, a Sub-Committee to prepare the framework of a Central Bill to regulate the wages and conditions of Employment of agricultural workers and to provide a machinery for the settlement of disputes and claims. This sub-Committee has finalised its report which will be considered along with other matters by the Central Standing Committee in its next meeting.

#### Productivity linked bonus formula.

These suggestions are receiving attention of the Government.

THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE): (a) and (b) No. Sir. While the liquidity position of the Steel Authority of India Ltd. (SAIL) has been adverselv affected due to certain factors as cost escalations, lower production severe constraints in the availability of coal and power, large build-up of steel ingot stocks as a result of inadequate availability power and so on, Government are continuously appraising the situation with a view to removing the bottlenecks and effecting improvements in its financial and physical health. Some of the important steps taken, or proposed to be taken, in this regard include optimisation of production through technological improvements, cost reduction efforts, maximisation of production of pig iron for sale, attainment of long term self-sufficiency by steel plants in regard to development finance, augmentation of captive power, generation capacity, improved methods of project planning, implementation and monitoring

and attempts at overcoming the shortages in the supply of coal and power by improved coordination with the concerned authorities.
