Exploitation of tourist potential from South Asia

- (a) whether it is a fact that large number of people of neighbouring countries in South Asia visit India as tourists and vice-versa;
- (b) whether the full potential of such traffic has been exploited;
- (c) if the answer to part (b) above be in the negative, what steps Government propose to take to promote tourism within the region; and
- (d) the estimated number tourists from neighbouring countries during the last three years, countrywise?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL CHANDULAL AVIATION (SHRI (a) to (c) While CHANDRAKAR): there is a substantial movement from the counof tourist traffic tries in South Asia to India and vice-versa, the tourist petential of this region has yet to be fully exploited. For this purpose, a regional marketing programme is being drawn up by the member-countries of the Asia Commission of World Tourism Organisation for promoting intra-regional tourism as also tourist traffic from other regions.

Salaries to employees of Nationalised Banks

1325. SHRI SYED SHAHABUDDIN: Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that the employees of the nationalised banks do not enjoy uniform scales of pay or conditions of service;
- (b) if so, whether any effort being made to evolve common scales of pay and conditions of service and also to institute common system categorisation of staff; and
- (c) whether any effort is being made to restrict operation in a district or region to one or two banks only in order to cut down cost of operation throughout a far flung area?

THE DEPUTY MINISTER IN THE FINANCE (SHRI MINISTRY OF MAGANBHAI BAROT): (a) and (b) Clerical and sub-ordinate staff in the Nationlised Banks have already had all along uniform pay-scales and similar conditions of service. For officers of the 14 Nationalised Bank identical pay-scales and conditions of service and a common basis for grading of officers, have been introduced.

(c) There is no proposal to restrict banking operations in a district region to one or two banks only. In the context of large gaps in rural credit structure, a multi-agency approach to rural financing is considered necessary in national interest. Under the
