THE MINISTER OF COMMERCE AND STEEL AND MINES (SHRI PRANAB MUKHERJEE); (a) The Mineral Concession Rules, J 960 framed under the Mines and Minerals (Regulation and Development) Act, 1957 contained rules governing grant of licence for prospecting for minerals including gems and other precious stones. These Rules apply alike to all mineralg excluding minor minerals and parties both in the private and public sectors.

Capacity utilisation im Public Sector Uelto

- (a) whether it is a fact that out of an analysis of 185 Public Sector Units in 1978-79, about a third of such units only have recorded a capacity utili sation of more than 75 per cent;
- (b) what were the comparative figures of capacity utilisation for the previous two years;
- (c) what are the reasons for this decline in capacity utilisation;
- (d) what was the position of capacity utilisation during 1979-80; and
- (e) what steps are taken to improve the position?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI MAGANBHAI BAROT); (a) and (b[^] Information relating to Capacity Utilisation in manufacturing units for the years 1976-77, 1977-78 and 1973-79 is furnished in the Public Enterprises Survey 1978-79—Annual Report on the Working of Industrial and Commercial Undertakings of the Central Government,, Vol. I, Chapter 14 (p. 166). It might be added that manufacturing units under construction in the initial stages of production and unitg in Defence sector, etc. in whose cases data are not available, have been excluded for working out the percentages (shown in brackets) in the information furnished.

- (c) A multiplicity of factors, both exorgenous and endogenous operate as constraints in production leading decline in capacity utilisation, such as power shortages, fluctuations and fai lures, inadequacy or poor quality raw material, old age of plant and equipment, equipment breakdown, dustrial managerial shortcom unrest, ings, etc.
- (d) On the basis of provisional information, it is estimated that 61 out of 133 units have recorded capacity utilisation over 75 per cent in 1979-80.
- (e) A number of steps have been taken by Government to improve the state of capacity utilisation, such as:
 - (i) provisioning 0f captive power equipment;
 - (ii) providing balancing facilities;
