

(c) The Gurukul Kangri Vishwavidyalaya, Haridwar, which is a registered Society, is functioning under the auspices of the Arya Pratinidhi Sabha, Punjab. There are protracted disputes between different factions of this organisation over the right to the administrative control of the Vishwavidyalaya. These disputes are subject matter of a Civil Suit pending before a Court.

#### Registration under OYT Scheme

1364. SHRI DHARAMCHAND JAIN: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether Government have resumed registration for "Own Your Telephone" scheme in Delhi; if so, what are the reasons therefor; and

(b) what is the present position of the lists for non-OYT applications, exchange-wise?

THE MINISTER OF COMMUNICATIONS (SHRI C. M. STEPHEN): (a) Yes Sir. OYT scheme was temporarily resumed registration for "Own Your vision of telephones to the Non-OYT applicants. This object has been achieved to some extent and therefore Government decided to revoke the suspension of OYT registration.
