the 4th plan has been continued during the 5th Plan and present Under the scheme, financial assistance is being provided to lav out demonstrations (@ 275/ha) on farmers' field to motivate them to adopt improved practices. The financial assistance is also provided to State Governments for seed multiplication for supply to farmere as given below:

(ii) Certified seed	150

25 per cent subsidy on the cost of plant protection chemicals (subject to a maximum of Rs. 30/ha depending upon the chemical used) is given for adoption of plant protection measures by the farmers in cultivation of pulse crops. In addition ground/aerial operational charges @Rs. 15/ha and Rs. 27.50/ha respectively for undertaking plant protection measures are also being given from 1980-81. Funds are also provided for strengthening and equipping the microbiological labs, and also as contingencies for production of rhizobium culture in large quantities for supply to the farmers for use in pulses cultivation.

During 1980-81, the administrative approval for an amount of Rs. 228.124 lakh has been accorded in which Central Government share is Rs. 163.403 lakh for implementation of Centrally Sponsored Scheme on development of pulses.

## Delay in phone call booking in Kerala

1407. SHRI S. KUMARAN: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether Government's attention has been drawn to the recent newspaper reports appearing in Malayalam Press regarding the delay in getting letters and phone call bookings in Kerala in general and Kottayam District in particular: and

(b) if so, what are the details in this regard and what steps are being taken to improve the situation?

THE MINISTER OF COMMUNICA-TIONS (SHRI C. M. STEPHEN): (a) The term 'delay in phone call bookings' is not clear. It is presumed that the honourable member means delay in answers from trunk call booking number. There are no significant delays in trunk call booking and delay in getting letters in Kottayam District and Kerala Circle. Occasional delays are sometimes observed due to staff absenteeism.

(b) Efforts are being made to reduce absenteeism by tightening discipline and supervision.
