deputation to various public sector undertakings, autonomous bodies, etc. prior to the 16th December, 1968 were allowed to retain their General Pool accommodation. Those who went on deputation after this date are not entitled to retain the General Pool accommodation allotted to them by the Directorate of Estates. In exceptional cases the Government have granted relaxation on merits of the individual cases

- (b) No. Sir, Government servants who are absorbed in autonomous organisations are not entitled to retain the General Pool accommodation. In exceptional cases Government have granted relaxation on merits of the individual cases.

Absorption of muster roll employees of C.P.W.D. Enquiry of Mehrauli-Badar-pur Road Quarters in regular posts

1376 SHRI PRASENJIT BARMAN: Will the Minister of WORKS AND HOUSING be pleased to state:

- (a) whether Government have received any representation from the Mustor Roll Employees of the C.P.W.D. Enquiry of Mehrauli-Badarpur Road Quarters, New Delhi, regarding absorption of their services in the Electrical Division No. XIII of the C.P.W.D. instead of terminating their services after handing over the quarters to Division-XIII;
- (b) if so, what action Government have taken or propose to take in the matter;
- (c) whether Government propose to absorb these employees on regular posts in Division-XIII of C.P.W.D.;
