Agency, the audited accounts for the accounting period upto 30th June, 1979 were ready in the month of March, 1980 and were approved by the Managing Committee on 17-3-1980. Thereafter, two instalments as indicated in part (b) above were paid.

The Agency has also reported that the Labour Commissioner had extended the date for payment in respect of the accounting period 1978-79, upto 31-5-1980.

New cooking gas connections

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI VEERENDRA PATIL): (a) The availability of cooking; g^a s in the country is anticipated to increase progressively from about the beginning $_0$ f 1981, with the commissioning of: __

- (i) Facilities for separation of LPG from Bombay High Associated GJas;
 - (ii) Mathura Refinery;
- (iii) Secondary Processing Facilities at Koyali Refinery.

The release of new gas connections on a large s^{ca} le will be possible for house-holders in various parts of the country after the completion of the above schemes.

- (b) and (c) With the anticipated availability of additional LPG it will be possible to extend marketing of LPG to more locations in the phased manner based on the following considerations:—
 - (i) Anticipated customer potential;
 - (ii) Nearness of market from source of supply;
 - (iii) Maximum utilisation of distribution $eQ^uiP^{men}t$; and
 - (iv) viability of operations.
