SHRIMATI AZIZA IMAM:

Will the Minister of COMMUNICATIONS be pleased to state:

- (a) what is the number of applications for telephone connections on the waiting list in Delhi as on the 31st March, 1980; and
- (b) what is the production programme of the telephone equipments (i) to wipe out the waiting list, (ii) to meet future demands and (iii) to replace the existing worn out equipment?

THE MINISTER OF COMMUNICATIONS (SHRI C. M. STEPHEN): (a) 59,707.

(b) The indigenous production of switching equipment is at extremely limited, ITI have at present a production capacity of 1.5 lakh lines of strowger equipment and 0.6 lakh lines crossbar 'equipment annually at Bangalore. The Telecom, factories of P & T are also producing manual switch boards at the rate of about 0.5 lakh lines an nually. From the Bangalore factories of ITI and the P & T Telecom. Factories, about 1.15 lakhs lines of local telephone exchange equipment is being supplied annually. The remaining production is used for applications like trunk automatic exchanges, PABX's, junction equipment, etc.

ITI is also setting up a strowger production factory at Rae Bareli which will have an annual capacity of 1 lakh lines. A factory to produce electronic switching equipment is also under installation at Palghat with a licensed capacity of 17,000 lines. The indigenous production of

switching equipment is further proposed to be expanded by setting up of crossbar production facilities for 2 lakh lines annually at Rae Bareli. Proposals are also under consideration for setting up additional units for production of electronic switching equipment.

In the meantime, to meet the gap between requirements of switching equipment and the supplies from indigenous sources, imports are being resorted to on a selective basis.

Irregularities in National Book Trust

The case has been referred to the Central Vigilance Commission for enquiry. Among other measures adopted by the Trust for proper maintenance of the paper account, new forms of registers including stock registers for off-cuts have been prescribed.
