than production in the corresponding quarter last year (January-March 1979) as also during the prequarter (October-December ceding This was achieved despite production constraints including power shortages, higher cost of raw materials and existence of old and obsolete technology which, in varying, degree affected individual units. The steps being taken to optimise utilisation of capacities include: better production planning, modernisation of plant and machienry adoption of appropriate technology, increased participation of workers in management¹ and' intensive monitoring and oordinatiori.
