(d) whether any survey has also been conducted; and

(e) if so, what is the outcome of the survey so conducted?

THE MINISTER OF PLANNING
(SHRI NARAYAN DUTT TEWARI):

(a) Government concern for correcting existing regional imbalances and for taking steps to prevent fresh imbalances dates back to the inception of planned development in the country. This approach has resulted in drawing up special programmes according to the conditions of each State, such as the Hill Areas and Tribal Areas Development Programme, the Drought Prone Area Programme, Command Area Development Programme, the Minimum Needs Programme, incentive schemes for the industrially backward districts etc.

Apart from these schemes, the formula for distribution of Central assistance is weighted in favour of those States whose per capita income is below the national average. Central assistance is also allocated for special problems.

(b) to (e) In view of (a), these questions do not arise.

States' draft proposals for the Sixth Five Year Plan

206. SHRI DHARAMCHAND JAIN: Will the MINISTER of PLANNING be pleased to state:

(a) whether it is a fact that the Planning Commission has asked the States to send their draft proposals for the Sixth Five Year Plan;

(b) whether it is also a fact that the Commission has also impressed upon the States that the size of the Sixth Plan would depend on their capacity to raise additional resources; and

(c) whether Government have examined the feasibility of raising resources by ways other than fresh taxation such as gearing up the administrative machinery to recover tax arrears, and constant review of plan proposals?

THE MINISTER OF PLANNING
(SHRI NARAYAN DUTT TEWARI):

(a) Yes, Sir.

(b) The State Governments have been informed that while attempt will be made to maintain the tempo of Central assistance for the State's Plans, they have also been requested to restrain non-plan expenditure, improve receipts and to raise more internal resources through fresh measures so as to accelerate the pace of development in the States.

(c) All possibilities of mobilising resources for the Five Year Plan—1980—85, including tightening of the administrative machinery to recover tax arrears etc. are being explored.

(e) what measures are being taken to ensure that the future Plan Documents are available before the Plan period begins?

(d) For the new Sixth Plan (1980—85), efforts are being made to complete the draft plan document by the end of the year for consideration by the National Development Council

soon thereafter. The Annual Plan for the current year, which is the first year of the new Plan, is being prepared having regard to the priorities of the Government and with the object of dovetailing it in the Five Year plan.

(e) It has been the practice to get a draft Five Year Plan considered by the Cabinet and the National Development Council and to prepare the final Plan thereafter. Steps are, therefore, initiated two years in advance of the period of the Plan to prepare the Five Year plan, it will be Government's endeavour to ensure that work on future plans is initiated well in advance of the period of the Plan.
