175/176 Triweekly Puri-New (fo)Delhi Neelachal Express has been routed via Bokaro Steel City and Tatanagar 'in order to connect the industrial centres of Bihar with New Delhi. The passenger_s to _and from Bokaro Steel City and the Steel Authorities had also been demanding a fast service to go to Delhi for a long time. Therefore, it is not desirable to divert Neelachal Express via Bankura or Purulia depriving these passengers.

Under-utiUzation of Calcutta Fort

268. SHRI GHOUSE MOHIUDDIN SHEIKH: Will the Minister of SHIP-PING AND TRANSPORT be pleased to state;

(a) whether it is a fact that the Calcutta Port is working below its capacity;

(b) if so, what are the reasons therefor; and

(c) what $step_s$ Government have taken to utilise the full capacity of the Port?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI A. P. SHARMA): (a) Yes.

(b) The primary reason has been limitation of draught which makes Calcutta Port in-accessible for medium and large sized vessels. Besides, the labour problems in the past contributed to under-utilization of the capacity.

(c) As regards draught limitation, technical studies are being carried out to determine the steps that could be taken for improving the situation. Incentive schemes have been adopted to ensure better productivity from the labour. Besides, efforts have been made to divert imports of cargo on Government account to Calcutta.
