## Late running of Asansel and Black Diamond Express

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) Punctuality performance of 305/306 Asansol Express and 307/308 Black Diamond Express trains has by and large, been satisfactory; despite various adverse factors. Punctuality of these trains was above 90 per cent in both Up and Down directions during periods December/79 to May/80.

- (c) Running of these trains as well as of other important trains is being watched daily and suitable action taken as warranted in cases of avoidable delay.
- (d) The proposal is under examination and will be decided on merits.
