V/ill the Minister of COMMERCE be pleased to state:

- (a) what steps Government aTe taking to augment the present stock of sugar in the country to meet the requirements in the coming months;
- (b) whether it is a fact that he is reported to have stated that there were enough sugar stocks in the country;
- (c) what are the reasons for import of sugar if there are enough stocks of sugar in the country; and
- (d) what steps Government have taken to, unearth the hoarded stocks of sugar?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI Z. R. ANSARI): (a) To meet the requirements of sugar for the remaining months of the present season as well as for the first two months of the next season i.e. October-November, 1980 the present stocks of sugar will be augment by importing sugar which is expected to arrive in June-July, 1980. Further, the Government are also working out the details of a 6cheme to provide incentives for early crushing of sugarcane which is meant

to Questions to augment stocks of sugar during the months of the October-November 1980 next.

- (b) No. Sir.
- (c) Sugar is being imported to meet (Interruptions) rising price trend caused by shortfall of production this year.
- (d) During the past few months, the Central Government has addressed a number of communications State Governments impressing them the desirability of strict enforce ment of the reduced stock-holding limits fixed for recognised dealers in February, 1980 and to intensify dehoarding operations in their area. Other steps taken unearth the to hoarded stocks are-
  - (i) restriction on sale of sugar by one wholesaler to another where the transaction is not accompanied by physical delivery of
  - (ii) restriction on recognised dealers for turn-over of stocks within 10 days period;
  - (iii) monitoring of information relating to sale and despatch of free sale sugar by making it obligatory for sugar mills to furnish particulars of weekly sales and despatches to the concerned State Government authorities.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI Z. R. ANSARI): (a) and (b) There has been no import of sugar since January '80 till date. A contract has been concluded with M/s. EDF Man (Sugar) Ltd., London, for import of 200,000 MT refined sugar On the period June-August '80.

(c) No amount has been paid as brokerage or service charges.

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE (SHRI Z. R. ANSARI): (a) No import of sugar wac made during this period.

(b) Contract has been concluded for import of 200,000 MT sugar. Arrivals are phased during June, July and August 19S0, depending on shipment schedules.

- (c) and (d) The Government decided to import sugar te meet persisting scarcity in the domestic market and rising price trend, arising from shortfall in sugar production this year. Government have initiated steps to augment sugar production in order to stabilise price.
- (e)' The estimated expenditure of the present contract is about Rs. 120.34 crores on landed cost basis. In terms of the contract, imported sugar may be 0\* any origin, except Israel and South Africa. Future imports will depend upon the indigenous crop and the sugar arrivals in the market in the coming geason.
