THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI C. L. CHANDRA-KAR): (a) Six double bedded cottages bearing serial numbers 5 to 10 have been destroyed by the sea erosion at the Temple Bay Ashok Beach Resort, Mahaballipuram, during period June to November, 1979.

- (b) The damage to the I.T.D.C. Beach Complex has been caused by the construction of the groyne wall near the shore temple.
- (c) The capital loss is estimated at Rs. 8 lakhs on the basis of replacement value of the six cottages.
- (d) The revenue earned by I.T.D.C. from Beach Resort during the last three years is indicated below:-
