(a) whether it is a fact that the Cutch Philatelic Association Bhuj have urged Government to issue a commemorative stamp in honour of Shri Shyamji Krishna Varma, the doyen of revolutionary movement of India;

(b) whether Government have any proposal to bring out a stamp in his honour; and

(c) if not what are the reasons herefor?

**Priority list for Type IV quarters in DIZ area, Delhi**

(a) whether it is a fact that Government maintains a priority list for giving change of 'D' (IV) type quarters;

(b) if so, what is the date of priority at present for change in respect of the first and the last person in the waiting list of persons who have asked for change for the 'D' type quarters in DIZ Area during the year 1979 and 1980 locality-wise;

(c) whether it is a fact that certain individuals have been given change for 'D' Type Quarters in the DIZ Area out of priority;

(d) if so, what are the names of such persons, their date of priority and reasons for which they were given change out of priority during the above period; and

(e) whether an enquiry is proposed to be instituted in the matter, if so, what are the details thereof;

(f) if not, what are the reasons therefor?

THE MINISTER OF WORKS AND HOUSING (SHRI P. C. SETHI)-, (a) Yes, Sir.

(b) The date of priority for change is reckoned from the date on which an applicant gets himself registered for change. However, the date of priority for allotment of type 'D' accommodation out of General Pool covered during 1979-80 was as follows:—

(c) Yes, Sir.

(d) (i) Shri O. P. C. Verma did not apply for change. His quarter came within the layout of quarters under construction and was required for demolition. He was, therefore, given change to type IV in 'Seemal Bagh' (DIZ Area).

(ii) Shri Anil Gupta, did not apply for change. His quarter came within the layout of quarters under construction and was required for demolition. He was, therefore, given change to type IV in Feshwa Road flats in DIZ Area.

(iii) Shri R. L. Bandlish applied for change and his serial No. in the Change Waiting list was 5074. His quarter was also required for demolition and he was given change in Peshwa Road flats in DIZ area.

(iv) Shri D. B. Ailawadi applied for change and his name on the Change Waiting list was 5844. However, he was allowed change on medical grounds.
