(b) There was no disruption during April, 1980. However, there were five outages during May and the first-half of June, 1980.

(c) Disruptions have been due to and problems of plant, equipment grid A thorough check of the moderator heat exchanger was undertaken. Leaky as well as potentially tubes have been indentified and plugged. At times grid voltage and frequency variations affect the performance of the unit and also cause outages. This matter is under tinuing discussion with the concerned -Electricity Boards and the Central Electricity Authority to formulate a long term solution to these problems. A continuous and ongoing review of operational problems is being carried out to improve the station's working.

Import of sophisticated foreign technical know-how by small scale industrial units

- (c) how much time the authorities are likely to take to clear such applications?

THE MINISTER OF STATE TN THE MINISTRY OF INDUSTRY (SHRI CHARANJIT CHANANA): (a) Government's policy in the field of import of technology is selective and based on national priorities. of technology is permitted only sophistication and high areas, in export-oriented or importsubstitution manufacturing, or for enabling indigenous industry achieve higher levels of technological sohphistication,

(b) An application for foreign collaboration is to be filed with the Secretariat for Industrial Approvals (Foreign Collaboration Unit), Ministry of Industry, Udyog Bhavan, New Delhi. The Secretariat issues approvals upon the recommendations of the Foreign Investment Board, as approved by the Minister for Industry.
