Agreements with Bangladesh over the Ganga Waters

THE MINISTER OF EXTERNAL AFFAIRS (SHRI p. V. NARASIMHA RAO). (a) and (b) According to Article XV of this agreement, the Agreement is to remain in force till Novem-»<er 1982 and it may be extended for a further specified period by mutual consent in the light of the review of this agreement, the first of which is «tue to take place during November ttiij year.

(c) and (d) Th_e two Governments kad exchanged their proposals for lotigterm augmentation of Ganga Waters in March 1978. Joint studies •f these proposals have not yet begun.

Normalisation of relations wttb Pakistan

696. SHRI SYED SHAHABUDDIIN: Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) whether Government have chalked out any proposals for fur ther normalisation of relations with Pakistan;
- (b) whether the categories for issue of visas are likely to be increased to include tourists and casual visitors;
- (c) whether the ban on entry of books and periodicals is likely to be revoked; and
- (d) whether exchange of goodwill visits by various professional groups e.g. lawyers, farmers, doctors, academicians etc. are likely to be promoted?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI P. V. NARASIMHA RAO); (a) The Simla Agreement is the basis of normalisation of relations between India and Pakistan. India i₃ honouring all it_s obligations under the Agreement and is willing to dw more.

- (b) Yes, Sir.
- (c) The matter is under consideration of the two Governments.
- (d) Government is working towards promoting goodwill visits by such professional groups.

Racket in the claims Department of Northern Railway

- 697. SHRI SAT PAUL MITTAL: Will the Minister of RAILWAYS be pleased to state:
- (a) what is the number of claims received by the Northern Railway during the last one year from the consignees of coal wagons for recovery of the cost of coal which are illegally diverted to power houses and locos;

- (c) whether Government are aware that there is a racket in the Claims Department of the Northern Railway whereby the original consignees are cheated of their consignments and their claims are purchased under duress by certain elements who are in collusion with the officials of the Claims Department as well as some-other functionaries in the Northern Railway Headquarters; and
- (d) whether Government propose to institute an inquiry into the matter with the cooperation of the Punjab Coal Merchants' Association?

Only after complete enquiries, could it be found whether these are due to public coal wagons being diverted to Power Houses or Loco Sheds.
