THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING TRANSPORT (SHRI BUTA SINGH): (a) and (b) The bus fares in the Capital are fixed/revised by the Delhi Transport Corporation with the approval of the Government. No proposal for revision of bus fare has so far been received by the Government from the D.T.C. A proposal for revision of bus fares is, however under the consideration of the Corporation to meet the increased cost of operation.

- (c) In order to streamline the functioning of the DTC, measures taken include:
- (i) Provision of Rs. 19.38 crores has been made in the annual outlay for various plan schemes including purchase of 630 new buses, development of related infrastructure such as construction of Second Central Workshop, depots and Bus Queue shelters.
- (ii) To achieve higher operational - efficiency, a jumping crew system on selected routes has been introduced whereby when one set of crew takes rest, another set operates the bus bringing in better utilisation of resources and serving more number of passengers.
 - (iii) On the organizational side, the whole time Chairman-cum-General Manager has been appointed since 12th May, 1980. The post was vacant since early October, 1979 during which period the stopgap arrangement had been made.

Request by European Shippers' Council regarding freight hike

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI BUTA SINGH):

(a) to (c) A Press report has come to the notice of the Government, according to which the European Shippers' Council at its meeting in Venice has requested the India-Pakistan-Bangladesh-UK/Continent Conference to defer the enforcement of the 20 per cent freight hike. Conferences are voluntary associations of shipping companies and are multinational in character. The Government of India does not control the fixation of freight rates by the conferences.

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) to (c) The survey in question has been included in the regular Budget for 1980-81 and will be taken up shortly after the estimate is sanctioned.
