Regarding Bird & Co. Ltd. according to present information, neither Shri Jit Paul nor Shri B. P. Bajoria nor Shri K. K. Birla have acquired controlling shares of Bird Group of Companies and the management of Bird & Company is not aware of any offer being made by them.

Regarding M/s. Willard India Limited, it is noticed from the Annual Report upto 29-2-1980 furnished by the company with the Registrar of Companies, Kanpur that the names of Sarvashri B. P. Bajoria, Jit Paul and K. K. Birla are not found in the list of top 50 shareholders and as such these persons cannot be said to hold controlling shares in the said company.

- (a) the average cost of production of coal in the country; and
- (b) whether there is considerable difference between the cost of imported and indigenous coal; if so, what is the percentage of difference?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) According to provisional unaudited accounts of Coal India Limited and the Singareni Collieries Company Ltd., the average cost of production of coal for the year 1979-80 is as follows:

Coal India Limited—Rs. 105.34 per tonne

Singareni Collieries Company Ltd.—Rs. 112.03 per tonne.

(b) Yes, Sir. The average price of the washed Indian Coking Coal is Rs. 280 per tonne whereas the cost Australia is around Rs 680 per of the imported coking coal from Australia is around Rs. 680/- per
