and Tamil Nadu arrived at during discussions on 14th October, 1965. It en-"visaged installation of 2 Units each of 50 MW in a power house discharging waters back into the Pandiar Punna-puzha system,, for use lower down in Kerala.

Work taken up on the project in 1969 was not actively implemented as Tamil Nadu subsequently undertook consideration of a scheme called Pandiar Moyar Project involving diversion of west flowing waters of Pandiar Punnapuzha into east flowing Moyar river

In January 1976, Tamil Nadu Electricity Board submitted revised estimates of the westward oriented Pandiar Punnapuzha Scheme at Rs. 46.3 crores. Subsequent to Central Electricity comments of Authority/Central Water Commission on this, the State authorities submitted a revised I project report on Pandiar detailed Punnapuzha Scheme in February 1977 at Rs. 73.9 I crores. The reservior level in the i revised scheme has been altered which per 1965 needs concurrence of Kerala as Agreement. Comments of Central Electricity Authority/Central Water Commission on this revised report have been made in 1977 and the Tamil Nadu authorities have also been asked to obtain and communicate concurrence of Kerala to the alteration in reservior level as per Agreement. These are being awaited.

Generic names on drug formulations

THE MINISTER OF PETROLEUM, CHEMICALS AND FEETILIZERS (SHRI VEERENDRA PATIL); (a) and (b) A statement is laid on the Table of the House.

Statement

- (a) and (b) Government, have decided that brand names shall be abolished in the first instance in respect of single ingredient dosage forms of the following five drugs:
 - 1. Analgin
 - 2. Aspirin
- . .3. Chlorpromazine
 - 4. Ferrous Sulphate
- 5. Piperazine and itg salts such as adepate, citrate and phosphate.

Government have also decided that Drug Controller should not, while granting permission, give recognition to brand names of new single ingredient drugs, nor should such drugs be allowed to be marketed under brand names when first introduced into this country.

Instructions have already been issued by the Ministry ol Commerce and civil Supplies to the Registrar of Trade Marks effective 1651[^] March, 1979 not to register any trade marks for single dosage forms of the above mentioned drugs and new single ingredient drugs when first introduced in India. These instructions are not, however, applicable to drugg meant for export.

- b) The total value of D.A.V.P. advertisements given to newspapers/periodicals during the financial year 1979-80 amounted to lis. 2783,31,408.
- (c) During the same period 27 Malayalam dailies were given advertisements by DAVP at a ^ cost of Bs. 14,95,407.00. The rates settled -with individual newspapers by DAVP are treated as confidential ag per normal trade practice.

Scheme for judicious use of oil and petroleum products

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL): (a) and . (b) No Sir, There is no scheme as such for judicious use of oil and petroleum Projecs to save at least 200 crores of foreign exchange by March 1981. However, the following are some of the important steps taken to hring aifiOut economy and efficiency in the

use of petrol and peffbleuni products in the country:

- <ii><i) Introduction of an improved version of Kerosene wick 8tov« possessing a thermal efficiency of about 60 per cent ^s against the thermal efficiency of 40 to 45 per cent possessed by other kerosene wick stoves usually gold in the market;
- (ii) Advising Central Govem-i ment Ministries [Departments^ State Governments and public sector xmdertakings to effect savings ift the consumption of motor spirit (petrol) in their staff cars;
- (iii) Initiating studies in the State Road Transport Undertakings, having a large fleet of vehicles, for greater efficiency in the utilisation of high speed diesel oil in the transport sector;
- (iv) Giving advise to State Governments to statutorily impose speed limits for passenger transport vehicles within cities and towns, and on local transport vehicles as well as to control goods and passenger vehicles with high smoke exhausts in order to achieve efficiency in diesel consumption;
- (v) Substitution of Furnace Oil by Coal, wherever it is technologically feasible;
- (vi) Providing advisory service to the industries for the adoption ol measures aimed at improvement of efficiency in the use of furnace oil.
- (vii) Issuing detailed guidelines for energy conservation;
- (viii) Assessing the feasibility of using a mixture of petrol and alcohol as fuel for motor vehicle*;
- (c) Partly only.
