Shri Awasthi was reverted to the post of Photographer on 2nd July, 1979 and his ad-hoc appointment as Senior Technical Assistant from 9-11-77 to 2-7-79 was regularised by the Executive Council of the Nehru Memorial Museum and Library as per assurance given to the Committee on Subordinate Legislation of Rajya Sabha.
