## Persons killed in police firing in Dlstricts of Assam

1076. SHRI AJIT KUMAR SHARMA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether there were poUce firing and acts of violence in North Kamrup and Duliajan in January, 1980 and also in Nowgong, Kamrup an<3 Goalpara districts of Assam in May, 1980;
- (b) whether any judicial enquiry have h>een made into these incidents and if so, what are the reports of such enquiries?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI YOGENDRA MAKWANA): (a) According to Assam Government, there were acts of violence in North Kamrup and Duliajan in January, ! 1980 and also in Nowgong, Kamrup I and Goalpara districts in May, 1980. Firing was resorted to in North Klamrup and Duliaian in January, 1980 and in Nowgong and Goalpara districts in May, 1980 to control violent mobs.

(b) No judicial enquiry has been ordered into these incidents.
