(b) whether the Government is aware that the Railway authorities use these motors after the normal life;

(c) whether these motors are repaired/maintained properly; and

(d) if not, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) Th_e 8-coach. Electrical Multiple Unit rakes have 8 traction motors. The 9-coach rakes have 12 traction motors. Some 9-coach rakes have 16 traction motors.

(b) Yes. If any motors are in good condition even after normal life, they are continued in use.

(c) Yes.

(d) Does not arise.

BHEL manufactured traction motors

1113. SHRIMATI KANAK MUKH-ERJEE: Will the Minister of RAILWAYS be pleased to state.

(a) whether it is a fact that the performance of the BHEL manufactured traction motors is not satisfactory; and

(b) if so, what are the details in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) Yes, performance of Bharat Heavy Electricals Ltd. manufactured Traction Motors fitted on suburban trains working in Calcutta area has not been found satisfactory.

(b) These Traction Motors have been found to be wanting in design and manufacture. In consultation with Bharat Heavy Electricals Ltd. Bhopal, ways and means are being devised to overcome deficiencies in commutators, fan and insultation system of the Traction Motors.

1114. SHRI SANGDOPAL LEPCHA; Will the Minister of RAILWAYS be pleased to state;

(a) whether the Government propose to increase the EMU coaches in the trains to cope with the rush; and

(b) if so, what are the details in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) and (b) The ENU trains in all cities are already running with full loads having regard . to the platform, signalling and other arrangements available at present except in case of some trains in Calcutta and Madras area. The trains in Calcutta will be augmented progressively on receipt of new EMU coaches.
