Captive power generation by private industries in Gujarat

- 1222. PROF. RAM LAL PARIKH: Will the Minister of ENERGY AND COAL be pleased to state:
- (a) whether it is a fact that due to inadequate supply of coal, Government of Gujarat is encouraging captive power generation by private industries to meet the shortage of power; and
- (b) if so, what measures have been taken or are proposed to be taken by the Central Government to supply adequate quantity of diesel for meeting the demands of private industries in Gujarat for captive power feneration?

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN); (a) The Government of Gujarat is encouraging captive power generation by private industries 'for meeting the shortage of power.

The Central Government has introduced a system of making monthly allocations of high speed diesel to the States and Union Territories since October 1979. These allocations are based on the past consumption and some growth rate for over the same has also been allowed. While the overall allocation of HSD are made by the Central Government the actual distribution of the product as between the different sectors, e.g. transport, industry for power generation etc. i<sub>s</sub> to be decided by the State Governments themselves.
