the Working Group on Energy Policy set up by the Planning Commission while submitting the report of the Working Group, had stated in the covering letter that a much larger oil exploration programme is warranted.

(b) No details of stepping up of exploration programme have been given in the Report; nor any figures on investment in oil exploration indicated. However, plans for intensification of oil exploration operations are being drawn up from time to time and are under implementation.
