SHRI KALYAN ROY: SHRI V. GOPALSAMY:

Will the Minister of ENERGY AND COAL be pleased to state:

- (a) whether Government's attention has been drawn to a news item "Remarks of Central Minister 'slanderous' " appearing in the Patriot of the 13th June, 1980 refuting his statement that the West Bengal Government had not approached the Centre with the demand for raising royalty on coal;
- (b) if so, whether the Central Government have received representations from the West Bengal Government regarding raising royalty on coal;
- (c) whether the Central Government have replied to the representations made by the West Bengal Government; and
- (d) whether any decision has been taken to increase the royalty on coal and if so, what are the details in this regard?
