Oil Refinery at Mangalore

1204. SHRI B. IBRAHIM: Will the Minister of PETROLEUM AND CHE-MICALS be pleased to state:

- (a) whether there is a proposal under Government's consideration for the setting up an oil refinery at Managalore; and
- (b) if so, what are the details in this regard?

THE MINISTER OF PETROLEUM, CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL): (a) and (b) Government are looking into the recommendations of an Expert Committee, set up to examine the question of creation of additional refining capacity after 1985-86, which has, inter alia, suggested Mangalore also as one of the possible locations for a new refinery.

Working capacity of collieries under the Coal India Limited

THE MINISTER OF STATE IN THE MINISTRY OF ENERGY (SHRI VIKRAM MAHAJAN): (a) and (b) Some of the collieries under Coal India Ltd. particularly in Bihar and Bengal area, have been working below capacity. The main reasons for lower utilisation of capacity has been the reduced coal out-put due to constraints like inadequate availability of power, uncertain law and order situation, and shortage of other essential inputs.
