- (c) whether Government are aware that some officials of the above Ministries who sought retirement last year have got jobs at fantastic salaries and perks in some industrial houses with which they were dealing while in services and these officials are instru- • mental in getting things done expeditiously and successfully; and
- (d) if so, what steps Government propose to take to stop such malpractices?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI S. D. PATIL): (a) No, Sir.

- (b) No, Sir. The provisions of these rules are applicable only to retired Group 'A' (Class I) officers. Among other reasons, Group 'B' officers have little scope and "authority for deciding important issues finally Or to finally dispose of cases: there is little scope for them to influence the Administration or give undue assistance to any commercial or private organisation, as such, such a restriction is not called for.

- THE PRIME MINISTER (SHRI MORARJI DESAI): (a) and (b) It is true that the cost of living index of industrial workers increased in April, 1979 by 5 points as compared in 332 in March, 1979 There was relative price stability during the last two years (1977-78 and 1978-79) the recent rise in the cost, of living index is a matter of concern
- (c) to (e) Planning Commission, on the basis of analysis of the various factor_s underlying the current price situation, made certain suggestions to the Government to check price rises. These, inter *alia*, included the economy in the non-development expenditure of the Central Government and impounding, for a specified period of time, a part of the additional emoluments (wages, bonus and dearness allowance), if granted, in future so as to avoid undue demand pressures.
