THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SAMARENDRA KUNDU): Yes, Sir.

(b) and (c) The matter has been the subject of discussion between* the two Governments through diplomatic channels.

The Malaysian Government has in formed us of the various steps they have already taken. We appreciate the seriousness with which the Government and people of Malaysia view these acts of vandalism and we are satisfied that they are taking adequate action to avoid their recurrence.

Replacement of D.T.C. Chairman

proposed to appoint a non-official part-time Chairman of D.T.C. in the near future to make the Corporation more responsive to the needs and aspirations of the people. The term of deputation of the present incumbent of the post of Chairman-cum-General Manager is proposed to be extended by another year as General Manager of the Corporation after his present term of deputation expires on 21st August 1979.

(d) The Board of D.T.C. would comprise of part-time non-official Chairman, whole time General Manager, five Government officials, one representative each of Municipal Corporation of Delhi, N.D.M.C. and Metropolitan Council of Delhi, and upto 5 non-officials appointed by Government.

Hindi as an Official Language in U.N.
