## Demands of Jipmer Hospital Employees' Union Pondicherry

392. SHRI ANANDA PATHAK: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to

state what action has been taken on the demands of Jipmer Hospital Employees' Union, Pondicherry?

THE MINISTER OF PARLIAMEN-TARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA): Of the two main demands of the Jinmer Hospital Employees' Union which have been received, one relates to the request for the recognition to Union for the purposes of representation in the JCM Council. There is also another association namely the Jipmer Hospital National Employees' Union, Pondicherry. For the purpose of JCM, recognition can be granted to only one association in institution. The matter is under consideration with a view to granting recognition to the association which has the largest number of employees and fulfilled the prescribed conditions and criteria. The Union has also protested against the grant of autonomy to the Jipmer. The conversion of the Institute into a registered society under the Registration of Societies Act is being considered for more effective functioning.

## Decentralisation of the Calcutta Central Food Laboratory

393. SHRI ANANDA PATHAK: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether it is a fact that Government have received representation dated 20th March 1979 from the Central Food Laboratory Employees' Association Calcutta against the decentralisation of the Calcutta Central Food Laboratory; and
- (b) if s<sub>0</sub> what steps have been taken for the revocation of the decision by the authorities on the decentralisation?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA): (a) Yes.

(b) The requirement of the Central Food Laboratories for the country was carefully examined. A decision was taken to set up a total of four such laboratories to serve the different zones of the country. Three more laboratories in addition to C.F.L. Calcutta have been notified as Central Food Laboratories from 1st April 1978. The question of revocation of this decision does not arise.

## Charter of demands submitted by the Federation of Pharmacists' Association

394. SHRI ANANDA PATHAK: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) whether he has received on the 16th May 1979 a copy of charter of demands of the pharmacists from the National Federation of Pharmacists' Association, Delhi; and
- (b) if so, what action has been taken thereon?

THE MINISTER OF PARLIAMENTARY AFFAIRS AND LABOUR (SHRI RAVINDRA VARMA): (a) Yes, Sir. A charter of demands from the Association dated the 16th April, 1979 has been received.

- (b) The position in regard to the various demands contained therein is as follows:
  - I. Implementation of the Technical Grade and Widening the Channel of Promotion.—The matter was earlier considered, but the demand of upgrading the scale of pay of Pharmacists could not be agreed to. The demand for increasing the Selection Grade posts from 10 per cent to 20 percent has been agreed to by the Govt. in respect of Pharmacists working in the CGH Scheme.

- II. Amendment to the Pharmacy
  Act and Abolition of Annual Registration Fee.—This question was earlier considered and it was felt that
  the system of annual registration
  fee should remain in force in order
  to keep the State Register and statistics up-to-date after taking into
  account the contingencies like death,
  migration, retirement etc. Abolition
  of this provision for Pharmacists,
  will therefore be a retrograde step.
  - of this category on the screen.—This has been brought to the notice of the Ministry of Information and Broadcasting who are concerned with the matter.
- IV. To stop Registration of qualified persons under the Drugs and Cosmetics Rules.—The Pharmacy Council of India have intimated that the period of operation under Section 32B(1)(b) of the Pharmacy (Amendment) Act, 1976, permitting registration of eligible qualified persons has already expired with effect from 31st August 1978.
