THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEELAHMAD): (a) and (b) Some complaints in the distribution of SIM cards were received from Eastern Uttar Pradesh. However on investigation, no irregularities were observed in the distribution of SIM cards.

(a) whether the performance of private sector in postal services are better than the services of Department of Posts;

(b) if so, the details thereof and whether this has affected the services of Department of Posts and Government have suffered loss due to this; and

(c) Government's reaction thereto and the steps taken by Government to get a lead over private sector in this era of competition?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEELAHMAD): (a) No. Sir.

(c) To meet the competition from couriers premium products like Speed Post, Express Parcel Post and Business Post have been introduced. A number of value additions, like free pick up, door to door delivery, Internet based track & trace, volume based discount and credit facility have been provided for the premium mail products. Numbers of booking counters and offices with late hours of booking have been increased. Further special attention is paid to the marketing and promotion of premium products. As a result of these initiatives premium products have shown a sustained increase in revenue over the years, which is evident from the table given in the enclosed Statement.
