(c) Due to the transport bottlenecks and the writ petitions filed by the sugar producers there was some delay in lifting the sugar from the factories which caused som_e shortage of sugar in the fair price shops. The lifting, of late, hag picked up and sugar is being rushed to variou* State Governments for their public distribution system.

- (d) The State Governments have been asked to take necessary action against the hoarders and black-marketeers under the Preventive Detention Act and other powers delegated to them.
- (e) and (f) In view of above there is no need to conduct any enquiry regardingrise in the prices of sugar. A number of steps have been taken to check the rise in the prices of sugar such as the monitoring of sugar prices on day-to-day basis by the Central and the State Governments, reduction of stocks holding limits of the licensed sugar dealers by 50 per cent, streamlining the movement of sugar from the factories, increase in the transport charges for road movement upto the Rail head allowed to the sugar mills, visit of high level teams to Maharashtra, U.P., etc., to sort operational problems, revalidating all the Lapsed quotas of levy sugar, removal of restrictions on the movement of khandsari from U.P. to other States and instructing the State Governments to take energetic steps against hoarders etc.
