(c) and (d) For the people working in the vicinity of Eastern Court, Jan-path etc. going to Trans-Jamuna area, the Corporation has provided two high frequency routes i.e. 310 and 320. In addition services of. route numbers 330, 369 and 380 originating from Central Secretariat and passing through Ferozshah Road are also available for going towards Trans-Jamuna area. In view of this, it is not proposed to start any special trip from Eastern Court on route numbers 320 and 310. The commuters avail these services from Ferozshah Road bus stop which is at a walkable distance from the Eastern Court, Traffic survey carried out at Ferozshah Road revealed that the existing services are meeting the requirements adequately.

The King informed the Prime Minister that his Government had offered Bhutanese citizenship to all Tibetan refugees resident in Bhutan and those who had accepted Bhutanese citizenship were welcome to stay on in Bhutan.
