JAFFAR SHARIEF): (a) to (d) A scheme for setting up a New Railway Carriage Repair Workshop at Mancheswar (Orissa) on the South-Eastern Railway to meet the requirements of Eastern Region was approved and included in the Railway's Works Programme for 1977-78. The Project Report and Estimates prepared by the South-Eastern Railway for setting up the workshop were approved in June, 1978 and the construction work is in progress.

A Scheme for setting up another New Railway Carriage Repair Workshop at Tirupati (Andhra Pradesh) on the South-Central Railway to meet the requirements of Southern Region has also been approved and included in the Railway's Works Programme for 1979-80. The Project Report and Estimates prepared by the South-Central Railway for setting up this workshop are under examination,

Boundary Agreement with Bangladesh

- (c) and (d) Prior to ratification of the 1974 Land Boundary Agreement by India, a Constitution (Amendment) Bill has to be adopted by the Parliament. Prior to drafting of this Bill, it has been considered advisable to demarcate the border so as to know precise areas of territories being ceded/acquired. The Government of Bangladesh have agreed for demarcation pending ratification of the Agreement by India and, in October 1979, a field programme for 1979-80 for demarcation etc. in Tripura and West Bengal Sectors was jointly chalked out by the Surveyors of the two sides. The demarcation work is in progress.
