Disposal of Unserviceable Transformers by DESU

- (a) whether it is a fact that DESU equipment including transformers worth several crores of rupees was disposed of during 1977-78 as being unserviceable:
- (b) whether it has been alleged that a conspiracy between the Government officials and the buyers has resulted in may losses to DESU; and
- (c) if so, what are the details in this regard?

THE MINISTER OF ENERGY AND IRRIGATION AND COAL (SHRI A.B.A. GHANI KHAN CHAUDHURY): (a) to (c) DESU has reported that some unserviceable equipment including transformers was sold by them during 1977-78, after observing necessary procedural formalities, to the tune of Rs. 40 lakhs (approximately) out of which the sale proceedes of unserviceable/damaged/burnt out transfor-Rs. 6 lacs accounted for (approx). Delhi administration has reported that no allegation were received by them involving Government officials and the buyers.

Hindi language programme from Jullundur T.V.

- (c) The programme 'Aaj Kal' actually replaces the programme of the same title earlier obtained from De'hi TV, and is now originated from Jullundur. 'Aapne Likha' has been adjusted by decreasing the duration of 'Chitrahaar', a programme of dance and music sequences from films, by 15 minutes.
