The rates of foreign allowance in respect of certain Indian Missions, including Tehran, Cairo and Hong Kong were revised/increased with effect from 1-1-1979.
- (c) The benefit of foreign allowance at revised rates ha3 already been extended to AIR Special Correspondent at Cairo. The case Special Correspondent at Tehran for sanction of foreign allowance at revised rates is being processed in consultation wh Ministry of External Affairs.

- (a) whether Government are aware of the acute shortage of power in the country leading to huge losses in industrial production and agriculture;
- (b) if ,0, what are the reason, follower shortage; and

(c) what ar_e short-term and long-term plan_s drawn by Government for power generation and what are the financial implications thereof?

THE MINISTER OF ENERGY AND IRRIGATION AND COAL (SHRI A. B. A. GHANI KHAN CHAUDHURY); (a) to (c) A statement is laid on the Table of the House.

Statement

- (a) and (b) A number of States are presently facing shortage of power. The main reasons for the power shortage are:-
 - (i) failure of the monsoons in some of the States, resulting in lower availability of the hydel power from hydro-electric power stations:
 - (li) increase in demand, particularly from Agricultural sector the du. unprecedented drought conditions prevailing in the States and change in cropping pattern in some states;
 - (iii) inadequacy of installed generating capacity to meet the increasing load demand; and
 - (iv) relatively poor performance of thermal power stations due to shortage of coal at some of the thermal power stations and poor maintenance at other stations

Shortage of power does affect agricultural and industrial production. Power supply to the agricultural consumers is, however, given on priority basis and as such the effect of power shortage on agricultural production is comparatively less.

- (c) A number of short-term and long-term plan_s have been taken for increasing power generation in the country. Tkese measures include:
 - (i) maximising generation from existing thermal capacity in the Central Sector. State Governments have al'o been advised to ,imilarly maximise generation from their thermal generating capacity;

(ii) addition of about 17122 MW of new generating capacity during the period 1978—83 involving a total outlay of about Rs. 9,272 crores on generation of power alone. About 3000 MW have already been commissioned during 1978-79;

- (iii) monitoring of coal stocks and ensuring availability of adequate coal to thermal power stations for maximizing generation from thermal power stations.
- (iv) arranging training for thermal power plant engineers and operators;
- (v) improving management of thermal power stations
