**Suggestions made by All India Small and Medium Newspapers Association**

356. SHRI N. K. P. SALVE: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether a meeting of the All India Small and Medium Newspapers Association was held in New Delhi in the last week of February this year;

(b) if so, what were the main observations and suggestions made therein; and

(c) what decision have been taken by Government in the light thereof?

THE MINISTER OF INFORMATION AND BROADCASTING AND SUPPLY AND REHABILITATION (SHRI V. P. SATHE): (a) to (c) Government had asked various Press associations/organisations including the All India Small and Medium Newspapers Association to furnish suggestions as to how the terms of reference of the Press Commission may be made more comprehensive. The Standing Committee of the Association held a meeting in New Delhi on 24th and 25th February, 1980, for this purpose and has made suggestions in this respect also covering the different aspects of functioning of the Press. All these suggestions will be given due consideration. These will also be kept in view while formulating the revised terms of reference of the Press Commission.

**All India T. V. link to watch programmes from any Station**

357. SHRI N. K. P. SALVE-SHRIMATI PRATIBHA SINGH:

Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether there is any proposal under Government's consideration to provide an all India T. V. link by 1981, whereby Television viewers in any part of the country could watch any programme telecast from any T.V. Station;

(b) if so, what are the details thereof; and

(c) whether necessary provisions therefor have been made in the National plan?

THE MINISTER OF INFORMATION AND BROADCASTING AND SUPPLY AND REHABILITATION (SHRI V. P. SATHE): (a) to (c) The Hon'ble Member is presumably referring to the proposals regarding the utilisation of the Indian Satellite 1N-SAT-I which will have the capability to radiate simultaneously two TV programmes to the entire country. This satellite is expected to become operational in 1981. A plan for the limited utilisation for Television of the ground segment of the satellite estimated to cost Rs. 46.73 crores covering the hardware aspects has been prepared. Details of this scheme are given in the Annexure. The software aspects of the scheme are being evolved keeping in view the development and extension requirements of the rural areas covered by the scheme. The scheme is not yet included in the Sixth Five Year Plan. It may also be mentioned that steps have been taken to link the TV stations Delhi, Bombay, Madras, Lucknow, Calcutta, Jullundur and Sri-nagar by micro-wave links. Of these, the Madras-Bombay link is already available and is being used by Doordarshan whenever required. The other links are likely to become available in phases during the period 1980-82. When these stations get connected, it will be possible for one station to relay the programmes of any other of these stations.
