- (a) the extent of increase in pay and allowances granted to the different categories of employees of public undertakings and Central Government Corporations such as L.I.C., Nationalised Banks, I.A.C. etc. during the past three years, category-wise and year-wise;
- (b) how far these increases compare with the increases in the pay and allowances of Central Government employees of corresponding categories;
- (c) how the present emoluments of the different categories of Central Government employees compare with those of the corresponding employees in the Central Government Corporations and Public Undertakings; and
- (d) what steps are being taken to narrow down the disparities between the remunerations payable to the Central Government employees and the employees in public undertakings and Central Government Corporations?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JAGANNATH PAHADIA): (a) to (c) Factual information will be collected and laid on the Table of the House.

(d) The disparities between the remunerations payable to the Central Government employeese and the employees in the public usdertakings and Central Government corporations arise partly due to historical factors and partly due to differences in the conditions of service and employment. The existence of these disparities and their extent is borne in mind at the time of considering proposals for revision of pay and allowances granted to the different categories of employees.

Bangladesh Nationals Employed in UCO Bank, Tezpur

897. SHRI AJIT KUMAR SHARMA: Will the Minister of FINANCE be pleased to state:

- (a) whther it is a fact that Bangladesh nationals have been appointed in the service of nationalised banks in the North-eastern region of India:
 - (b) if so, how many;
- (c) whether Government are aware that a foreigner appionted by, and in the service of, the United Commercial Bank of India at Tezpur was recently arrested; and
- (d) if so, what action has been taken against that foreigner and those responsible for appointing them?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI JAGANNATH PAHADIA): (a) and (b) Government is not aware of any Bangladesh nationals being appointed in the service of nationalised banks.

- (c) The United Commercial Bank have reported that one of its employees at Tezpur, one Shri Makhan Lal Sinha was arrested in Tezpur on the allegation of his being a Bangladesh national but was subsequently released on bail on 6-3-80. From the information available in the records of the bank Shri Sinha is an Indian national and has been appointed in the bank from 16-7-1969.
 - (d) Does not arise.
