Guidelines for feme of bonus shares by companies

*195. SHRI KALYAN ROY: SHRI JAHARLAL. BANERJEE: **SHRI BHOLA** PRASAD;

Will the Minister of FINANCE be pleased to state:

- (a) whether Government propose to revise the guidelines for the issue of bonus shares which were considerably liberalised in the last lew years;
 - (b) if not, what are the reasons therefor;
- (c) what is the total amount involved in the issue of bonus shares in 1978, 1979 and 1980 till date;
- (d) what are the names of com panies which issued these shares in 1978, 1979 and 1980 till the date and details thereof, including the number of shares issued and the amount in volved in each case;
- (e) whether Government propose to investigate into the fact that a large number of companies which have been issuing bonus shares are guilty of non-payment of provident fund and wages of workers, evasion of taxes and other serious economic offences and are facing prosecution; and
 - (f) if not, what are the reasons therefor?

THE MINISTER OF FINANCE AND INDUSTRY (SHRI R. VENKATA-RAMAN): (a) to (f) A statement is laid on the Table of the House

Statement

(a) and (b) There is no proposal for review of the guidelines before the Government at present. Guidelines for issue of bonus shares are kept under review and are revised, as and when it is considered necessary to do so, in the light of all relevant facts and circumstances.

to Questions:

(e) and (f) The capitalisation of reserves and issue of bonus shares K essentially a book keeping transactioa to bring the shareholders' funds more in line with the capital permanently employed in the business. It does not lead to any cash outgo from the company or to depletion of its funds. In terms of the guidelines governing the issue of bonus shares, companies wil* have to satisfy inter alia the residual reserve test (which requires that the residual free reserves are not less than one third of the enlarged capital base) and the profitability test (whk3i requires that 30% of the average *pre* tax profits for the last three years should yield a return of at least 9% on the enlarged capital base). Ordinarily financial position of companies guidelines-would be isound and it is these highly unlikely that they may be in default of payment of provident fund and wage dues, etc., and may be facing prosecution.
