**THE MINISTER OF COMMERCE, CIVIL SUPPLIES AND STEEL AND MINES (SHRI PRANAB MUKHERJEE):** (a) Alloy Steels Plant, Durgapur and Visvesvaraya Iron & Steel Limited, Bhadravati are allowing credit facilities to their customers on commercial consideration on the merits of each case. The sale of materials on credit by these steel plants is not in contravention of the credit squeeze by the Reserve Bank of India.
