grade was resorted to in the various Commissioners' charges on different dates, and the question as to the basis on which confirmations of the promotees and direct recruits should be made, has now arisen.

- 2. The position in regard to matter is that confirmation is the last stage in the process of recruitment. Confirmations should accordingly be made on the basis of the quota prescribed in the recruitment rules direct recruitment and promotion. The Board have, therefore, decided that all the LDCs promoted on a 100 per cent basis should be confirmed first and thereafter the available permanent vacancies should be utilised for confirmation on 50:50 hasis.
