These transfers are, however, undertaken in a phased manner in consultation with the Ministries/Departments concerned and subject to the overall administrative requirements.

Traffic rush on Baba Kbarag Singh Margr, New Delhi

1073. SHRI V. G. KESAVA BAO: •Will the Minister of HOME AFFAIRS be pleased to state;

(a) whether it is a fact that there is a heavy traffic rush on Baba Kharag Singh Marg near General Post Office, New Delhi, threatening accidents for pedestrians;

(b) whether Government propose to provide speed breaker and traffic lights on this road for the safety of pedestrians;

(ic) if so, what ar_e the details in this regard; and

(d) if not, what are the reasons therefor, and what other steps are proposed to be taken to prevent traffic hazards on this road?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AF-FAIRS, (SHRI YOGENDRA MAK-WANA): (a) Yes, Sir. There is heavy rush of traffic on Baba Kharag Singh Marg near General Post Office but there is no threat to pedestrains' safety.

(b) and (c) Traffic light blinkers are already provided. Ag for speed breakers, it is not practicable to provide them on road getting a Jot of traffic.

(d) Following steps have been taken to prevent traffic hazards on this road:—

(1) The road is 60' wide with footpath of 20' width on both sides,

(2) Near G.P.O., New Delhi, opposite Gurudwara Bangla Sahib, Zebra crossing (double) has been provided for pedestrains.

(3) On Baba Kharak Singh Marg, blinkers have been provided near Gurudwara Bangla Sahib to caution motorists.
