- (a) whether it is a fact that the Commissioner for Scheduled Castes and Scheduled Tribes in the report for the period 1978-79 submitted to Government he has suggested that unlaw. ful eviction of Harijans or Tribals from the land in their possession by anybody be made a cognisable offence and also to post special police force in sensitive areas where atrocities on them persist or are continuing; and
