(b) and (c) On hearing the sound of firing, BSF patrol rushed to the place of incident, but by that time, dacoits escaped to Bangladesh taking advantage of the darkness. To prevent such incidents, the Border Out Posts have been strengthened and all BSF units have been alerted and patrolling in the area has been intensified.]

Press report regarding industrialisation of Bombay
