THE MINISTER OF STATE IN THE MINISTRY OF HEALTH (SHRI NIHAR RANJAN LASKAR): (a) and (b) But for Dr. Ram Manohar Lohia Hospital where some of the Staff resorted to strike from 5th to 21st December, 1979 which caused inconvenience to the patients, the other hospitals functioned smoothly.
