JAFFER SHARIEF): (a) Work on the underground Railway Project in Calcutta is in progress along the length from Dum Dum to Belgachia, through Chitpur Yard and from Esplanade to Tollyganj. shield tunnelling contract tunnelling work between Chitpur and Shyambazar has been awarded and the work taken up. The prototype rolling stock is under manufacture in the Integral Coach Factory, Madras. Tenders for some of the contract sections between Shyambazar and Esplanade are under consideration.

The overall physical progress of construction work upto date is 22 per cent

NARASIMHA RAO): (a) and (b) The King of Bhutan had informed us of his intention to exchange resident diplomatic missions with Bangladesh in September 1979. Bhutan has since set up an Embassy in Dacca on January 8. 1980 Bangladesh has also opened an Embassy in Thimphu on the same day. Bhutan has no plans to open diplomatic missions in Washington and Peking at present

#### Congestion at major ports

The position at Bombay and Madras, however, has considerably improved in the recent past. Of late, there has been some improvement at Calcutta also.
