THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI C. K. JAFFER SHARIEF): (a) At Delhi and New Delhi Stations, there are comprehensive departmental catering arrangements and only fruit® and miscellaneous articles are sold by licensed contractors. At Nizamuddin there are both departmental and con-

Vacant Railway Land in and Around Delhi

- (b) what are the reasons for not licensing or leasing out the vacant land; and
- (c) what are the norms and conditions laid down by the Railway Board or Zonal Railways to licence/ or lease out Railway land other than cultivable land and for how long?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI C. K. JAFFER SHARIEF): (a) The vacant land comprising an area of about 111 acres, is in addition to (and not included in) 651 acres, which have already been licensed for agricultural and other purposes, Locality-wise disr
