This was purely to meet the professional needs and requirements. There was no intention whatsoever to sup-ress the views expressed by anyone and there was no question of any censorship.

The Government's policy in regard

to broadcast/telecast of view3 of the Opposition Parties is for the media to present a fair and balanced flow of information including contrasting views without advocating any opinion or ideology of its own and to maintain a non-partisan, and fair approach in the treatment of news and other programmes.

ttTHE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI SHIV SHANKAR); (a) About 950 written complaints were received by the Election Commission regarding omission of names of voters from the electoral rolls for the recently concluded elections to the Lok Sabha. No specific complaints regarding the presence of the names in the Hindi lists of electoral rolls but of their absence in the English lists of the rolls, were received by the Commission.

- (b) Most of the complaints received in the Commission do not give information regarding the number of persons whose names have been omitted from the electoral rolls. It is, therefore, not possible to ascertain on the basis of these complaints the number of voters whose names have been struck off from the electoral rolls.
- (c) The Election Commission is convening a conference of the Chief Electoral Officers on the 1st February, 1980 *inter alia*, to discuss ways and means of checking such omission of names from the electoral rolls in fu-
- i ture and devising better methods of preparation and maintenance of electoral rolls up-to-date.]
