- (c) what is Government's reaction to the complaints received in this connection and what action Government propose to take in this regard?]

विधि, न्याय श्रौर कम्पनी कार्य मंत्री (श्री शिव शंकर) : (क्ष) हाल ही में सम्पन्न हुए लोक सभा के निर्वाचनों के लिए निर्वाचक नामाविलयों में से मतदाताश्रों के नामों के लोप के संबंध में निर्वाचन श्रायोग को लगभग 950 लिखित शिकायतें प्राप्त हुई हैं। इस संबंध में कोई विनिर्दिष्ट शिकायतें श्रायोग को प्राप्त नहीं हुई हैं कि निर्वाचक नामाविलयों की हिन्दी सूची में तौ नाम मौजूद हैं किन्तु निर्वाचक नामाविलयों की श्रंग्रेजी सूची में वे नहीं हैं।

†[THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI SHIV SHANKAR): (a) About 950 written complaints were received by the Election Commission regarding omission of names of voters from the electoral rolls for the recently concluded elections to the Lok Sabha. No specific complaints regarding the presence of the names in the Hindi lists of electoral rolls but of their absence in the English lists of the rolls, were received by the Commission.

- (b) Most of the complaints received in the Commission do not give information regarding the number of persons whose names have been omitted from the electoral rolls. It is, therefore, not possible to ascertain on the basis of these complaints the number of voters whose names have been struck off from the electoral rolls.
- (c) The Election Commission is convening a conference of the Chief Electoral Officers on the 1st February, 1980 inter alia, to discuss ways and means of checking such omission of names from the electoral rolls in future and devising better methods of preparation and maintenance of electoral rolls up-to-date.]

GHANI KHAN CHAU-DHURI): (a) and (b) Reports have been received from the Gujarat State Electricity Board about the inadequate supply of coal to Thermal Larger supplies would have been possible if additional transport capacity had been provided since adequate stocks were available at the pitheads. It has been reported that on occasions Gujarat State Electricity Board have restricted generation in view of low level of stocks at the power stations.
